## Image Reproduction and Use

Images in the Charleston Archive at the Charleston County Public Library (CCPL) may be accessed and viewed by the public free of charge. Requests for reproductions of and permission to use these images incur certain fees and are subject to conditions. The material contained below describes the conditions of use and related fees. An Image Use Request Form, included below, must accompany each request for image reproduction and permission to use. Each request will be handled as efficiently as staff time permits, and thus CCPL cannot guarantee a date of response or delivery. ### I. Conditions for Use

- **Rights:** CCPL grants the applicant the non-exclusive right to use each image one time. Any subsequent use of the image constitutes a re-use, and the applicant must submit in advance a request for permission to use the image(s) for each instance. This permission cannot be transferred to any other individual or party.
- **Internet Use:** All policies included herein apply to the use of CCPL images in Internet publications or displays. Applicants may request permission to use an image for both print and Internet use simultaneously. Images used in such online presentations will be low-resolution jpeg files.
- **Credit:** All images from CCPL used for display, publication, or broadcast must be accompanied by a caption acknowledging its source. The proper citation is “Courtesy of Charleston County Public Library.”
- **Alteration:** Alteration of a CCPL image, such as a layover, crop, removal, etc., through digital means or otherwise, must be approved by CCPL in advance of its publication, display, or broadcast.
- **Products:** The applicant will furnish CCPL with two *gratis* copies of the finished product (e.g., book, magazine, pamphlet, DVD, etc.).
- **Original Photography:** Some materials in the Charleston Archive are too fragile to be scanned or photocopied. At the Library’s discretion, such materials can be professionally photographed. All resulting negatives, transparencies, and/or digital files, and prints thereof, must be surrendered to CCPL, with the rights to reproduce the same at the CCPL’s discretion. The resulting photographs may not be sold or transferred to another individual or party. When requested, CCPL will stipulate that the photographer’s name will be credited along with the CCPL. Before publication of any photograph not provided by CCPL, a photographic proof of the image must be approved by CCPL. Remember, permission to photograph materials in CCPL’s possession does not alone constitute permission to publish.
- **Television, Video, Film, Electronic Equipment:** CCPL will permit camera crews to film in the Charleston Archive under certain conditions. A written request for permission to film must be received at least two weeks before the requested date. Conditions specified for original photography (see above) apply.
